The Riverwood Athletic Club Community Association (RACCA) Annual Meeting was held on Wednesday, March 14th at 6:00pm in the Riverwood Middle School Media Room. The Management Company verified all ballots were issued to authorized voters and all proxies presented were valid. Per the Governing Documents, a Quorum was not present. As a quorum was not present, the Annual Meeting was adjourned to be held at a later date in accordance with the Bylaws.

The date for the adjourned Annual Meeting has now been scheduled for Wednesday, March 28th at 7:00pm in the Riverwood Middle School Media Center. Pursuant to N.C.G.S. 47F-3-109(c), the quorum for this meeting will be ½ of the quorum requirement for the original meeting held on March 14th.

The agenda for the Annual Meeting includes the election for one member of the Board of Directors to serve a 2-year term. Per section 3.4 of the By-Laws, the Board of Directors have appointed a Nominating Committee and Mike Langston is the Chairman. Any Member or representatives of Members can serve on the Nominating Committee. Nominations will also be taken from the floor the night of the election. All nominees will have an opportunity to introduce themselves before the election.

Per section 2.9 of the By-Laws, each Member may vote in person (if a corporation, partnership or trust, through any officer, director, partner or trustee duly authorized to act on behalf of the Member) or by proxy, subject to the limitations of North Carolina law. Each proxy shall be in writing, shall specify the Unit(s) for which it is given, and shall be signed by the Member or its duly authorized attorney-in-fact, dated and filed with the Secretary of the Association prior to any meeting for which it is to be effective.
